A BILL

To direct the Secretary of Homeland Security to issue guidance with respect to space systems, services, and technology as critical infrastructure, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Space Infrastructure
5 Act”.

1 **SEC. 2. SPACE SYSTEMS, SERVICES, AND TECHNOLOGY AS**
2 **CRITICAL INFRASTRUCTURE.**

3 (a) IN GENERAL.—Not later than 30 days after the
4 date of the enactment of this section, the Secretary shall
5 designate space systems, services, and technology as a crit-
6 ical infrastructure sector.

7 (b) GUIDANCE.—Not later than 180 days after the
8 date of the enactment of this section, the Secretary, in
9 consultation with relevant agencies and departments of
10 the Federal Government, the Assistant to the President
11 for Homeland Security and Counterterrorism, relevant
12 Federal advisory committees, and the Executive Director,
13 shall issue guidance with respect to designating space sys-
14 tems, services, and technology as critical infrastructure,
15 including—

16 (1) defining the scope of such sector, including
17 satellites and space vehicles, space-related terrestrial
18 systems and launch infrastructure, space-related
19 production facilities, and applicable information
20 technology;

21 (2) designating Sector-Specific Agency for
22 space systems, services, and technology; and

23 (3) identifying appropriate committees and
24 advisories to accompany such sector, including Gov-
25 ernment Coordinating Councils and Sector Coordi-
26 nating Councils.

1 (c) REPORT.—Not later than 90 days after the Sec-
2 retary issues guidance pursuant to subsection (b), the Sec-
3 retary shall submit to the appropriate congressional com-
4 mittees a report relating to the following:

5 (1) The implementation of such guidance re-
6 quired under subsection (b).

7 (2) Any other information the Secretary deter-
8 mines appropriate.

9 (d) CONFORMING AMENDMENTS.—Section 2001(3)
10 of the Homeland Security Act of 2002 (6 U.S.C. 601(3))
11 is amended—

12 (1) by redesignating subparagraphs (O), (P),
13 and (Q) as (P), (Q), and (R), respectively; and

14 (2) by inserting the following new subpara-
15 graph:

16 “(O) Space systems, services, and technology.”.

17 (e) DEFINITIONS.—In this section:

18 (1) APPROPRIATE CONGRESSIONAL COMMIT-
19 TEES.—The term “appropriate congressional com-
20 mittees” means—

21 (A) the Committee on Homeland Security
22 of the House of Representatives; and

23 (B) the Committee on Homeland Security
24 and Governmental Affairs of the Senate.

1 (2) **CRITICAL INFRASTRUCTURE.**—The term
2 “critical infrastructure” has the meaning given such
3 term in section 1016(e) of the USA Patriot Act of
4 2001 (42 U.S.C. 5195c(e)).

5 (3) **EXECUTIVE DIRECTOR.**—The term “Execu-
6 tive Director” means the Executive Director of the
7 Space Information Sharing and Analysis Center.

8 (4) **SECTOR-SPECIFIC AGENCY.**—The term
9 “Sector-Specific Agency” has the meaning given
10 such term in Presidential Policy Directive 21 (Feb-
11 ruary 12, 2013; relating to critical infrastructure se-
12 curity and resilience).

13 (5) **SECRETARY.**—The term “Secretary” means
14 the Secretary of Homeland Security.
